You can now donate money to your Valencia High School PTSA simply by purchasing your groceries from your local Ralphs Grocery store. Our PTSA is an authorized participant of the Ralphs Community Program. By registering your Ralphs Rewards Card on-line, Ralphs will donate up to 4% of your purchases to our PTSA. Last year our VHS PTSA raised over \$2,000 by our parents simply shopping at Ralphs. It's really that easy and 100% of the money we earn through this program goes directly to benefit Valencia High School and our students.

There are **TWO** ways to register for the program. Keep in mind that you must register after **August 31, 2010**.

1. **Take the scan bar that is printed on the back of this sheet with you to Ralph's** and hand it to the cashier along with your Ralph's rewards card and the cashier will enroll you in the program at the register.

2. If you prefer, you may enroll on-line by following the step by step instructions below:

- Log in to <http://www.ralphs.com>
- Click on the School Programs link in the bottom middle section of the home page, the third item listed under the "Services" section
- On the next page, scroll down to the Community Contribution section and click on the "Learn More" tab
- On the next page, scroll down to the "Participant" section and click on the enroll tab
- On the next page, click on the "Sign up today!" tab under the New Customer? section or sign in if you have an existing account
- Follow the prompts on the next page and please enter Valencia High School PTSA as your organization
- The Valencia High School PTSA NPO number is 90914

If you don't currently have a Ralphs Rewards card, please sign up at the customer service desk at your nearest neighborhood Ralphs store. Then start shopping at Ralphs and be sure to carry your Rewards Card with you. Every time you shop at Ralphs and swipe your Rewards Card, you will be donating to your Valencia High School PTSA. VALENCIA HIGH SCHOOL PTSA:

Thank you for your interest in the Ralphs *rewards* Community Contribution Program. We are happy to be a part of your fundraising.

Here is your Organization's Scanbar code as requested. This supplemental process allows your members without access to a computer to be a part of your fund raising through our Community Contribution Program.

How it works

- Make copies of this form and give the copies to members of your organization who wish to enroll with your organization, but do not have access to register online.
- DO NOT remove these instructions from this letter. These instructions are necessary for the cashier in order to process the link between your card and your organization at the register.
- Participants take this form the next time they go shopping at Ralphs and hand it to the cashier to scan within their order IN ADDITION to either their Ralphs *rewards* Card, or phone number entry that is linked to their *rewards* card.
- Within 72 hours, your participants will then begin giving a percentage of each shopping trip for the duration of the Community Contributions Term to your organization.
- You only have to scan this letter once to create the link between your card and your organization. You must continue scanning your Ralphs *rewards* Card/phone number during all purchases to get credit for your organization.

IMPORTANT INFORMATION!

- 1) If your participants register for the Community Contribution Program using this Scanbar method, the name of your organization **WILL NOT APPEAR** on the receipt.
- 2) If your participants register for the Community Contribution Program using this Scanbar method **AND do not have their correct information updated in the Ralphs *rewards* Card Database, their name will not appear on your quarterly statements.**
- 3) Any attempt by the organization to reproduce this scan bar (other than copying it) in any other format could result in your organization not receiving credit.
